Payroll Investigations

Nick has been engaged to conduct numerous payroll investigations, reviews and audits. These engagements have been in the context of litigation (class-actions and Employment Tribunal matters) as well as for internal use for organisations to identify and/or quantify wage underpayments.

In this regard, Nick was responsible for investigating and quantifying potential underpayments in respect of approximately 2,500 employees, spanning a seven-year period. This involved the interrogation of over 50 million data points, including detailed time data, pay data and fingerprint data in order to calculate potential underpayments under various interpretations of the relevant industrial instruments applicable from time to time.
- → Payroll compliance audits involving public sector agencies, private businesses, not-for-profits and major private schools in South Australia, which were aimed at identifying instances of non-compliance with relevant industrial instruments.
